Since early 2006 I have been involved with several major oil companies performing due diligence at their fuel storage facilities performing operational upgrades to fixed assets, Additionally I did the same for water bourn facilities. I have been the on-site facility inspector for several fuel cold flow, dye injection, bio-diesel and ethanol/gas blending systems at many truck loading racks. Two of these projects lasted about six months each. Recently I completed a thirty rail car train off-load (ethanol) into two ethanol storage tanks, and a bio tank installation, plus truck rack loading. In Dec. 2009, completed an comprehensive inspection of a chemical storage water bourn facility. Completed working on terminal updates of operating procedures for a major pipeline facility. Currently on-site over-seeing the start-up construction of joining a 12 inch and a 8 inch pipeline together of two major pipeline oil companies, while performing duties as the on-site inspector for the construction of a terminal rack bio-diesel ofload, and terminal rack two bay load rack.
